MEMORANDUM OF UNDERSTANDING Between

QUEEN MARY'S COLLEGE

And

IAOYS, a duly registered and recognized Non-Profit Yoga Academy, with postal address at No-S4 Orchid Plaza, No-85, Razack Garden Main Road, MMDA Colony, Arumbakkam, Chennai-600106, Tamilnadu, India, represented by its ADVISOR, **Prof. Dr. A.M.Moorthy** (Former Vice Chancellor of Tamil Nadu Physical Education and Sports University).

1. Purpose

QUEEN MARY'S COLLEGE and the IDENTITY ACADEMY OF YOGA SCIENCE share a mutual mission to develop research and education in yoga, with the objective of promoting co-operation, the QMC and the IAOYS, individually as "party" and also collectively as "Parties", enter into the following Memorandum of Understanding ("MoU").

B. PRINCIPAL

2. Forms of Co-operation

Within such fields as are mutually acceptable for both Parties, the following forms of cooperation, amongst others, may be pursued hereunder:

- Mutual recognition of each Party including the use of the term 'Technical Partner' on websites and other promotional materials;
- Commitment to undertake best efforts to co-operate and collaborate on activities i.e. conferences, conducting certificate course and Diploma in Yoga and academic projects.
- Commitment to not pursue any activities that may damage the other party or the partnership.

3. Specific Co-operation Projects

Specific co-operation projects, for instance within such fields as described in section 2 above, may be negotiated separately between the Parties and may be established in separate written agreements, stating the respective rights and obligations of the parties. In case of any ambiguity or conflict of terms between the terms and conditions of this MoU and those of a separate agreement as mentioned above, the terms and conditions of such separate agreement shall prevail.

4. Mutual membership

In order to facilitate effective coordination, each party commits that at least one individual from each Party shall retain a full membership of the other Party's Association.

5. General Coordinators

Each Party shall designate an individual to oversee and facilitate the implementation of any agreements arising out of this MoU. These individuals are:
