PUBLIC VIVA-VOCE EXAMINATION

10.5 The Candidate, whose thesis has been recommended for the award of the degree by the Board of Examiners who valued the thesis, shall submit himself/herself to a Public Viva-Voce Examination conducted by the Supervisor and one External examiner appointed by the Vice - Chancellor in the Department where the research work was conducted. A copy of thesis of the candidate appearing for the Public Viva-Voce examination shall be deposited in the Department library for perusal of those interested in the thesis before the conduct of Public Viva-Voce examination. Members of the department in the subject concerned where the candidate conducted research and outside specialists if any, may participate in the Public Viva-Voce examination. The Supervisor - Convener shall convey to the University the result of such Public Viva-Voce examination duly endorsed by the External examiner together with the list of Participants in the examination with their signature, designation and address. The candidate who is successful at the Public Viva-Voce Examination shall be declared to have qualified for the Ph.D., Degree by the Vice- Chancellor.
